

STUDENT MATINEE POLICIES AND PROCEDURES

Reservations

- Please fill out the digital <u>Student Matinee Reservation Request Form.</u>
- Submission of a Student Matinee Reservation Request Form is not a guarantee of a reservation. If Fantasy Playhouse Children's Theater & Academy (FPCTA) is able to accommodate your request, a Reservation Confirmation will be sent via email at our soonest convenience.
- If you do not receive a Reservation Confirmation please contact us at <u>FieldTrips@fantasyplayhouse.com</u>.
- A minimum group size of 10 is required to make and maintain a reservation for a Student Matinee performance.
- All Student Matinee Productions take place at the VBC Playhouse, 700 Monroe
 St. SW Huntsville, AL 35801. Schools/Organizations arriving by car will be
 responsible for finding and paying for parking in the city or VBC lots/garages.
 Please stay tuned for bus drop off and pick up procedures. We will contact your
 group lead with this information.

Tickets

- Tickets for Student Matinee performances are \$10 per person for educational groups of 10 or more.
- FPCTA provides 1 complimentary ticket for Accompanying Adults per 10 students.
 (ex: A class of 20 would be allowed to have two accompanying adults free of charge)
- All Student Matinee sales are final. Paid tickets cannot be refunded or exchanged.
- FPCTA does not provide refunds or exchanges for unused tickets. FPCTA does not provide refunds or vouchers for anyone absent on the day of performance.
- Tickets cannot be resold for profit or transferred to another performance date or time.
- Included with the price of tickets is a study guide for each student that helps to relate the performance to Alabama Core Curriculum.

Final Numbers/Cancellation Deadline

- Adjustments to your final reservation numbers may be made no later than two
 weeks prior to performance, also known as the Final Numbers/Cancellation
 deadline. All requests for adjustments to final numbers or cancellations must be
 submitted in writing and are subject to availability.
- After the Final Numbers/Cancellation deadline passes, you are responsible for payment for all seats in your reservation.
- If you find you need additional seats after the Cancellation Deadline, please email FieldTrips@fantasyplayhouse.com and we will fill requests on a first come first serve basis, if available.

- If you would like to book a student matinee performance after the Final Numbers/Cancellation Deadline for a particular show has passed, please email FieldTrips@fantasyplayhouse.com to check availability.

Payment

- Payment is due in full two weeks prior to performance via check, credit card, or cash.
- Invoices will be emailed to your Group Lead Contact.
- Reservations unpaid upon deadline may be released at FPCTA's discretion and may forfeit any tickets reserved.
- There will be a \$30 fee for any checks returned by the bank.
- Refunds will be issued only if FPCTA cancels a performance. Groups will be notified in advance of any cancellations.

COVID-19 INFORMATION

The health and safety of our staff, families, and audiences remains our number one priority. Masks are currently optional for in-person programming at Fantasy Playhouse Children's Theater & Academy (FPCTA). This includes programs at the VBC Playhouse. Due to the ever-evolving nature of COVID-19, this policy is subject to change and may fluctuate from "masks optional" to "masks required" at any time during the duration of our 2023-2024 Season. No refunds are granted due to policy changes. Patrons that are not feeling well, have tested positive, or have potentially been exposed to COVID-19, or if anyone in their immediate family has been exposed or tested positive, should stay home for at least 5 days. Please notify FPCTA if you or a family member have been exposed or diagnosed. There is an inherent risk of exposure to COVID-19 in any public place or group gathering. This includes Fantasy Playhouse Children's Theater and Academy in-person programming. While we have taken the fullest safety measures possible to reduce the risk of exposure and infection, by participating in our in-person programming, you voluntarily assume all risks related to exposure to COVID-19 and any of its variants.
